#### **Introduction :**

As Lyytinen (1985) pointed out, "man uses language to express feelings and attitudes and to establish, coordinate, and control relationship with others". Due to this English is considered as an international language around the whole world. That is why the one who wants to speak English should memorize lots words .The words that are really hard to memorize are frequently the small, common words, whose meaning depends on context. Besides, the native language of a learner is connected to some particular difficulties in learning and using the English language and the sort of mistakes a student makes in English, whatever this mistake is. On the other hand when the student is supposed to speak in English for communications that occur daily he /she must remember the words and use them properly with their correct pronunciation. This research paper critically investigates the problems faced by students in the language classroom at Al-majd Private school in Riyadh. Also it cites remedial measures for the successful rectification of these problems too.

#### Literature review:

In previous studies, there are many researchers wrote about my subject:

\*In studies on Saudi students, it was disclosed that most English learners blundered in their writing skills making most of their English teachers to complain of deteriorating mastery in learning English language. In yet another study, Zughoul (1984) affirmed those conclusions.

Decarrico (2001) states that:words should not be learnt separately or by memorization without understanding. Moreover, "learning new words is a cumulative process, with words enriched and established as they are met again"

Nation (2000, p.6). Therefore, the "look and remember" way of vocabulary learning seems to be not very effective for learners of the English language.

Newton (2001) refers to this approach as a way that can enable learners to manage their vocabulary meaning and develop their communicative skills at the same time. Many experts of language teaching methodology also agree that playing games is a good way to learn vocabulary.

Mukattash (1983) divides the problems that Arab learners of English face into two types. First,

University students continue to make some basic errors in pronunciation, spelling, and morphology and syntax. Secondly, they continue to be unable to express themselves "comfortably and efficiently either when dealing with 'academic topics' or 'common everyday topics' (1983:169).

#### Significance of Research:

The research is expected to help enhancing the methods of teaching/learning EFL in the schools of Saudi Arabia in general and improving the language learning level for the students who are engaged in this study and the whole school in particular. Also it will give more recommendations about helping the students and the teachers at Al-majd Private school in Riyadh to handle and solve the problems related to learning the English language vocabulary. As a result the students who are participating in the study will face their problems related to learning the vocabulary in English language .Moreover, they will know the reasons for these problems and with the help of the study they can have some solutions for their problems. Even more, they can express their own ideas about how they can encounter these problems.

## **Expected Results:**

There are diverse problems that are affecting the learning process at the classes of English language among the students in the Arab countries. These problems vary from one student to another. According to the data I collected in my research expect that the problems connected to the learning of the English language vocabulary among the students of Al-majd Private school in Riyadh are:

- There is a huge social distance between the English culture and the Arabic culture.
- The traditional methods in teaching are used most of the time inside the classes.
- Students do not understand or use properly the English difficult vocabulary.
- Parents feel afraid about their daughters' and sons' proficiency of English.
- Students experienced problems with English spelling.
- The students failed in using English as a tool of self-expression to achieve their communicative goals to study plans and methods of teaching.

In conclusion, Students in Saudi Arabian schools need to be thoroughly self-guided.
